DECISION

Entities Authorized to Conduct Export & Import of Armament and Military Equipment, Brokerage Services and Technical Assistance given that the Decision Number: 300-12-080-00048/2010-12 of July 16th 2010, on which basis the above entity was entered into the mentioned Register ceased to be valid on July 16th 2015, due to expiry of 5 year period of validity of the Decision prescribed by the Law.
